## What is SuperStream? And how does it affect me?

---

The ATO has recently implemented changes to the reporting of employer super contributions that could affect you. This new reform is called SuperStream.

From 1 July 2014, self-managed superannuation fund (SMSF) trustees are required to register for an Electronic Service Address (ESA) to receive electronic messages and payments associated with employer contributions, using the SuperStream data and payment standards.
