## New - Small Business Depreciation Rules

---

For the year ending 30 June 2013 there are new depreciation rules in place for small businesses.

The most significant changes are as follows:

1. The small business instant asset write off threshold has changed. Under the old rules, if an asset cost less than \$1,000, the asset could be fully written off in the year it was purchased. Under the new rules that apply from 1 July 2012, if the asset costs less than \$6,500 it can be fully written off in the year that it is acquired.
2. An accelerated depreciation system applies to Motor Vehicles from 1 July 2012. The first \$5,000 of the cost of the motor vehicle can be fully written off in the year it is acquired. The remaining cost of the motor vehicle is then added to the

General Pool and is depreciated at 15% in the year it is acquired. The depreciation rate is 30% for subsequent years.
